



Silverton Casino's "NFR 2021 Return to Vegas Giveaway"

Official Rules

Contest Duration

1. Qualifying period for the "NFR 2021 Return to Vegas Giveaway" (the "Promotion") shall be from Wednesday, December 2, 2020 through Saturday, December 12, 2020 (the "Promotion Period") unless earlier terminated at the sole discretion of the management of Silverton Casino, LLC (the "Silverton").

Eligibility

2. The Promotion shall be open only to persons who are 21 years or older at the time of entry.
3. Must be a legal resident of the forty-eight (48) contiguous United States of the District of Columbia ("D.C.")(the "Eligible States") and is void where prohibited by law.
4. All Silverton and Stockyards Development Company employees and officers, together with their immediate family members are not eligible to participate in or claim any prizes associated with this Promotion.

How to Enter

5. During the Promotion Period, you may enter by going to <https://silvertoncasino.com/nfr-vegas/> and providing all the information required for entry. Such information may include, but may not be limited to, your full name, address, city, state, ZIP code, daytime phone number, date of birth and email address. All entries must be received by 11:59pm CT (9:59pm PT) on December 12, 2020.
6. Participants may earn entries (also known as "Points") by following Silverton Casino on Twitter (2 Points) (mandatory for entering the Promotion), Visiting Silverton Casino's website (2 Points)) (mandatory for entering the Promotion)and Tweet about the Promotion (1 Point) (optional).
7. Limit five 5 entry(s)/point(s) per person during initial entry and one (1) entry/point per person per day thereafter.

Daily Drawing

8. Beginning Thursday, December 3, 2020, Silverton will select one (1) potential daily prize winner at 12pm CT (10am PT) to win two (2) Plaza level seats for the 2020 National Finals Rodeo in Arlington, TX.
 - a. Rodeo tickets will be valid for the same night as the drawing. For example, if the winner's name was drawn on December 3, tickets will be awarded for the December 3 performance.

Grand Prize Drawing

9. On December 13, 2020, Silverton will select one (1) potential Grand Prize winner of the grand prize package described below in a random drawing from among all eligible entries received during the Promotion Period. The potential winner must meet all eligibility requirements set forth in these Official Rules and comply with these Official Rules to qualify for the prize.
10. The Grand Prize consist of the following:
 - a. A 3-day, 2-night stay (resort room) at Silverton Casino Hotel December 2 – December 4, 2021
 - b. Two (2) Gold Buckle tickets for NFR performance on Dec 3, 2021

11. All prize details are at the Silverton's discretion and are subject to change. Event tickets are subject to certain terms and conditions specified thereon.
12. Prize is nontransferable. If winner chooses to travel without a guest, no compensation will be awarded in lieu thereof.
13. Winner is responsible for all federal, state and/or local income taxes on the prize. If total ARV of the Grand Prize is \$600 or greater, winner will be issued an IRS Form 1099 for the value of the prize.
14. All prizes are subject to verification and approval by Silverton and, if necessary or appropriate, the Nevada State Gaming Control Board.

Claiming the Prize

Daily Drawing

16. Winners from the daily drawing will have until 4pm CT (2pm PT) on the same day of the drawing to claim their prize. Winners will be notified via email/text provided at the time of entry. Once a winner has been verified, tickets will be digitally transferred.

Grand Prize Drawing

17. Following the Grand Prize Drawing, Silverton will attempt to notify potential prize winner at the phone number or email address provided at the time of entry. If the potential winner cannot be reached after reasonable efforts have been made (as determined solely by Silverton in its discretion), if notification is returned as undeliverable, if potential winner is determined by Silverton to be ineligible or if the potential winner does not comply with the Official Rules in any way, s/he will be disqualified and at Silverton's discretion, an alternate potential winner may be selected via random drawing from among the remaining eligible entries (time permitting).
18. If the winner is unable to accept the prize as described herein for any reason, the prize will be forfeited and may be awarded to an alternate winner in a random drawing from among the remaining eligible entries.

Publicity Consent

Disputes/Choice of Law

All issues and questions concerning these Rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded that are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and not resolved pursuant to a regulatory decision set forth in NRS 463.362, shall be: Resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada state, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;

Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will you be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

Any attempt to deliberately undermine the legitimate operation of the promotion may be a violation of criminal and/or civil laws and should such an attempt be made, Silverton reserves the right to disqualify and seek damages or other remedies from any person responsible for such attempt to the fullest extent permitted by law.
