## “Las Vegas Football Suite Giveaway”

2023–Rules

### Contest Duration

1. Silverton Casino, LLC, (“Silverton”) “Las Vegas Football Suite Giveaway”, (the “Promotion”) shall run from 12:01a.m. PT on Friday, September 1, 2023, through 4:59p.m. PT Thursday, December 28, 2023, unless earlier terminated in the sole discretion of the management of Silverton.

### Promotion Eligibility

2. The Promotion is open to all registered Silverton Rewards Club account members based on casino rated play.
3. Drawing entries may be earned playing any slot reel machine, video poker or table game at Silverton, beginning 12:01am PT September 1, 2023, through 4:59pm PT December 28, 2022. Promotion is open to anyone 21 and older, Membership in Silverton Rewards Club is required to be eligible, and to claim any prize or reward.

### How The Promotion Works

4. One (1) entry will be earned by a Silverton Patron for every five hundred (500) base slot reel, video poker and table game points earned.
5. Entries will be electronic, and check-in is required on the day of each drawing by the Patron. Check-in will begin at 3:00p.m. PT and continue up until 4:59p.m. PT.

Thursday, December 28, 2023-Win (2) stadium suite tickets-Denver on January 7, 2024
7. Drawings will be held on each specified drawing date at 5:00p.m. PT at the Silverton Box Office.
8. No max entries. All entries earned by gaming on casino floor will roll over to the next available drawing dates. Entries are cumulative throughout the Promotion period and will not be discarded after each drawing.
9. One (1) winner at each drawing will be randomly drawn using the Everi computer drawing system to determine the winner of the Promotion.
10. Available prizes for the Promotion are as follows:
  - Two (2) Stadium Suite tickets to a Las Vegas Football home game (approx. retail value \$3,636) along with transportation to/from Allegiant Stadium.
  - Winner and guest must take Silverton shuttle to the stadium to receive their tickets.
  - Tickets may not be re-sold or transferred.
11. Replacement names will not be drawn, any and all unclaimed prizes from each drawing time and or date will be forfeited.
12. Patrons drawn from the Everi computer drawing system will be announced over the casino PA system and posted at the Silverton Box Office for 24hrs and must be claimed by 5:00p.m. PT the following day. If Patron does not claim within the 24 hour claim period, prize will be forfeited.

### Miscellaneous Rules

13. Valid identification is required for all Patrons. “Valid identification” is defined as a current valid form of one of the following: state-issued driver’s license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If winner is not a U.S citizen, a current valid passport or alien registration card is required.
14. The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an “advantage player,” to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such “advantage

player” who is already a Silverton Rewards Club member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such “advantage player” will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.

15. Employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.
16. In the event the Everi computer drawing system malfunctions or fails in any way, Silverton shall, for the convenience of the guests, attempt to repair the drawing system that same evening. If the computer drawing system cannot be repaired by 9:00 p.m. that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any prizes not distributed due to any malfunction or failure of Everi computer system will not be redrawn at a later time.

Your participation in this Promotion shall be deemed an act of affirmative assent by you that you clearly understand and fully accept and agree to all Promotion rules, terms and conditions and all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Rewards Club desk.

#### **Disputes/Choice of Law**

All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
29. **ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.**
