



Rock Around the Tree Drawings Rules-2023

Contest Duration

1. Qualifying period of the "Rock Around the Tree" Interactive Drawing" (the "Promotion") shall be from 12:01a.m. PST on Friday, December 1, 2023, through 6:59p.m. PST Saturday, December 30, 2023, unless earlier terminated in the sole discretion of the management of Silverton Casino, LLC (the "Silverton").

Eligibility

2. The Promotion is open to all registered Silverton Rewards Club account members.

How The Drawings Promotion Works

3. One (1) entry will be earned by a Silverton Patron for every fifty (50) base slot, video poker and table game points earned.
4. No max entries. All non-winning entries will be discarded weekly following Saturday's drawings held on December 9th, 16th, 23rd, 30th, 2023.
5. Entries will be electronic, and check-in is required on the day of the drawing by the Patron. Check-in will begin at 5:00pm PST and continue up until 6:59pm PST each Saturday.
 - a) Patrons must activate entries by inserting their Silverton Rewards Club card into a slot or video poker machine and generating a play rating, Patrons must pull their Silverton Rewards Club card out prior to 6:59pm PST to ensure all entries are activated.
 - b) Patrons can also activate entries by swiping at the redemption kiosks on the floor.
 - c) It is the sole responsibility of the Patron to have their entries activated by 6:59pm. PST. No exceptions will be made to adjust entries or activate entries after 6:59pm PST.
6. Each Saturday, December 9th, 16th, 23rd, 30th 2023, at 7:00 p.m. PST, ten (10) winners will be randomly drawn using the Everi computer drawing system to determine the winners of the Promotion.
7. The drawing area is in front of Mi Casa Grill and Cantina Restaurant, Patrons will have three (3) minutes to claim once their name and card number is announced, Patrons must be present to win.
8. If the drawn patron or a representative of a drawn patron fails to notify a Silverton drawing official in the drawing area located in front of Mi Casa Grill Cantina Restaurant within the three (3) minute time frame, and or fails to show a valid form of ID and Silverton club card they will be ineligible to claim, replacement names will continue to be drawn until all ten (10) winners are verified.
9. Each Patron with a confirmed winning entry may participate in the "Rock Around the Tree" game for a chance to win up to \$10,000 cash.

How The Rock Around the Tree game works:

- a. Each Patron with a confirmed winning entry may choose a numbered "Decal" to initially stand on.
- b. Decals are numbered #1 through #12.
- c. Decal "selection" is based in order of which a Patron was "Drawn" from the Everi computer drawing system, not in which a Patron claims.
- d. Once the music begins patrons will walk clockwise, stepping on a new number in front of them.
- e. When the music stops, Patrons will land on their final number. The final number will determine which numbered "Present" they will receive from the Tree.
- f. Only One number per Patron is permitted.
- g. Presents will be opened to reveal the Patron's prize amounts.

The available Prizes for the Promotion is as follows:

- Five (5) Presents contain \$250 in Free Slot Play each.
- Four (4) Presents contain \$500 Free Slot Play each.
- Two (2) Presents contain \$1,000 Free Slot Play each.
- One (1) Present contains \$10,000 Cash.

Miscellaneous Rules

10. In the event that the Everi computer drawing/kiosk system malfunctions or fails in any way, Silverton shall make every attempt to fix the kiosk system that same evening. In the event that Everi system cannot be repaired by 9:00p.m. PST, that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any entries not distributed due to any malfunction or failure in Everi system will not be redrawn at a later time.

11. Your participation in this Promotion shall be deemed an act of affirmative assent by you that you clearly understand and fully accept and agree to all Promotion rules, terms and conditions and all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Rewards Club desk.
12. By participating in the Promotion, each winner gives the Silverton permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes. As a condition of the redemption of any prize in this Promotion, You agree that you shall execute an all-rights-of-publicity release, an affidavit of eligibility and a liability release.

14. The Silverton reserves the right to alter or cancel any portion or all of this Promotion for any reason at anytime and without notice, in its sole and absolute discretion.
15. All Patrons participating in the Promotion must be at least twenty-one (21) years of age.
16. All employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.
17. All prizes are subject to verification and approval by the Silverton and, if necessary or appropriate, the Nevada State Gaming Control Board.
18. Valid identification is required for all winners. "Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If winner is not a U.S citizen, a current valid passport or alien registration card will be required.

20. Cash winner must complete a 1099 and W9 form.

All issues and questions concerning these Rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded that are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and not resolved pursuant to a regulatory decision set forth in NRS 463.362, shall be: Resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada state, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;

Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will you be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
