



Golden Riches Hot Seat Promotion

Rules-2024

Contest Duration

1. The Silverton's Golden Riches Hot Seat Promotion (the "Promotion") shall be held on Tuesday, January 30, 2024, from 10:00a.m. PST through 6:00p.m. PST.

Eligibility

2. The Promotion is open to registered Silverton Rewards Club account members who are actively gaming on a slot reel machine, video poker machine, or video keno machine on the casino floor.
3. Patrons must actively coin in a minimum of ten dollars (\$10) to be eligible to participate in the Promotion.
4. Winners will be determined solely on a machine selected by SuperPlayMate random selection, not by Player/Patron.
5. Patron must have his or her own Silverton Rewards Club card properly inserted in the machine and actively gaming to be eligible.

How the Promotion Works

6. Between the hours of 10:00a.m. PST through 6:00p.m. PST on Tuesday, January 30, 2024, Silverton will randomly award three (3) winners each hour one hundred (\$100) dollars in free slot play.
7. Plus! If there is a patron actively playing on the immediate left or right of the winner, they will also receive twenty-five (\$25) in Free Slot Play each. The current Patron playing must be playing with his or her own card.
8. Winners will be notified by Silverton's Prize Patrol.
9. If a different Patron is seated at the machine at the time of arrival of the Prize Patrol than was selected by SuperPlayMate system, the current Patron seated at the machine is the winner. However, the current Patron must be playing with his or her own card.
10. Table games are excluded from the Promotion.
11. Patrons must play with their own Silverton Rewards Card; failure to do so will result in forfeiture of any free slot play prize.
12. Patrons playing more than one machine at a time with the same Silverton Rewards Cards will result in forfeiture of any prize.

Prize Redemption

13. Silverton will make reasonable attempts to notify prize-winners of any prize won and shall not be responsible for a Patron leaving his or her slot reel machine, video poker machine, or video keno machine prior to the Silverton Prize Patrol's arrival.
14. Free slot play is non-transferable, valid 30 days from the date issued.

Miscellaneous Rules

15. Valid identification is required for all Patrons. "Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If winner is not a U.S citizen, a current valid passport or alien registration card is required.
16. The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an "advantage player," to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a Silverton Rewards Club member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.
17. Employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.
18. In the event that the SuperPlayMate computer system malfunctions or fails in any way, Silverton shall make every attempt to fix the SuperPlayMate system that same evening. In the event that the SuperPlayMate system cannot be

repaired by 10:00 p.m. PST that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any prizes not distributed due to any malfunction or failure in SuperPlayMate system will not be redrawn at a later time.

19. Your participation in this Promotion shall be deemed an affirmative act of assent by You that You clearly understand and fully accept and agree to all Promotion rules, terms and conditions and to all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Rewards Club desk.
20. By participating in the Promotion, each winner gives the Silverton permission to have photographs taken of each winner and to use his or her name and/or likeness for advertising and publicity purposes. As a condition of the redemption of any prize in this Promotion, You agree that You shall execute an all-rights-of-publicity release, an affidavit of eligibility and a liability release.
21. Prizes are non-transferable.
22. The Silverton reserves the right to alter or cancel any portion or all of this Promotion for any reason at any time and without notice, in its sole and absolute discretion.
23. All Patrons participating in the Promotion must be at least twenty-one (21) years of age.
24. The Silverton shall not be responsible for any typographical or other errors in the printing, the offering or the administration of this Promotion, or which may result from the announcement of a winning ticket and its prize.
25. All prizes are subject to verification and approval by the Silverton and, if necessary or appropriate, the Nevada Gaming Control Board.

Disputes/Choice of Law

By participating in the Promotion, you also hereby agree that:

26. All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;
27. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
28. **ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.**
