## **Boat Load of Cash Drawings**

### **2024-Rules**

#### **Contest Duration**

1. Qualifying period of the **Weekly “Boat Load of Cash” Drawings** (the “Promotion”) shall begin at 12:01a.m. PDT on Friday, March 1, 2024, through 8:59p.m. PDT Saturday, April 27, 2024, unless earlier terminated in the sole discretion of the management of Silverton Casino, LLC (the “Silverton”).
2. Qualifying period of the **Grand Finale “Boat Load of Cash” Drawing** (the “Promotion”) shall begin at 12:01a.m. PDT on Friday, March 1, 2024, through 5:59p.m. PDT Tuesday, April 30, 2024, unless earlier terminated in the sole discretion of the management of Silverton Casino, LLC (the “Silverton”).

#### **Eligibility**

3. The Promotion is open to all registered Silverton Rewards Club account members.

#### **How The Saturday Weekly Drawing Promotion Works**

4. Drawing will be held every Saturday, March 9<sup>th</sup>, 16<sup>th</sup>, 23<sup>rd</sup>, 30<sup>th</sup> 2024 through April 6<sup>th</sup>, 13<sup>th</sup>, 20<sup>th</sup>, 27<sup>th</sup> 2024.
5. One (1) entry will be earned by a Silverton Patron for every one hundred (100) base reel slot, video poker and table game points earned.
6. No Max entries. All non-winning entries will roll over each hour, to the next available drawing session. All entries will be discarded by 9:01p.m. PDT, weekly following Saturday’s drawings held on March 9<sup>th</sup>, 16<sup>th</sup>, 23<sup>rd</sup>, 30<sup>th</sup>, April 6<sup>th</sup>, 13<sup>th</sup>, 20<sup>th</sup>, 27<sup>th</sup> of 2024.
7. Entries will be electronic, and check-in is required on the day of the drawing by the Patron. Check-in will begin at 4:00p.m. PDT and continue up until 8:59p.m PDT.
  - a) Patrons must activate entries by inserting their Silverton Rewards Club card into a slot or video poker machine and generating a play rating, Patrons must pull their Silverton Rewards Club card out prior to 5:59p.m. PDT to ensure all entries are activated.
  - b) Patrons can also activate entries by swiping at any Silverton redemption kiosks on the floor.
  - c) It is the sole responsibility of the Patron to have their entries activated by 5:59p.m. PDT. To be eligible for all drawings held at 6:00p.m., 7:00p.m., 8:00p.m. 9:00p.m. PDT. No exceptions will be made to adjust entries or activate entries after 8:59p.m. PDT on each drawing date.
1. 12. Entries will be electronic, and check-in is required on the day of the drawing by the Patron. Check-in will begin at 4:00p.m. PDT and continue up until 5:59p.m. PDT.
