



## ***“Play for Prime Rib Dinner”***

### **2024- Rules**

#### **Contest Duration**

1. Silverton Casino, LLC’s (“Silverton”) “Play for Prime Rib Dinner” Promotion (the “Promotion”), shall be held each Tuesday, April 2<sup>nd</sup>, 9<sup>th</sup>, 16<sup>th</sup>, 23<sup>rd</sup>, 30<sup>th</sup>, 2024, from 12:01 a.m. PDT through 11:59p.m. PDT, unless earlier terminated at the sole discretion of management of Silverton Casino, LLC (the “Silverton”).

#### **Eligibility**

2. The Promotion is open to all Silverton Rewards Club account members who meet the gaming requirements.

#### **How The Promotion Works**

3. Qualified Patrons may earn and redeem their Promotion voucher at any Silverton Redemption kiosk. Patrons must present their Silverton Rewards card and a valid photo ID to redeem the Promotion voucher at Sundance Grill.
4. Patrons may earn only one (1) voucher per promotion day.
5. Earn four hundred (400) same day base points for a Promotion voucher good towards a petite cut prime rib dinner at Sundance Grill, served from 11:00a.m. until 10:00p.m.
6. The promotion voucher max value is \$20, valid one day from date issued, valid on Tuesday or Wednesday only.
7. Eligible base points may be earned by playing video reel slots or video poker or table games at Silverton.
8. Bonus point multipliers will not count towards base points earned.
9. All Promotion vouchers must be redeemed at a Silverton Redemption kiosk before 11:59p.m. PDT on each promotion day.
10. Patrons must play with their own Silverton Rewards Club Card; failure to do so will result in forfeiture of all points earned towards the Promotion.

#### **Miscellaneous Rules**

11. Valid identification is required for all Patrons. “Valid identification” is defined as a current valid form of one of the following: state-issued driver’s license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If the winner is not a U.S citizen, a current valid passport or alien registration card is required.
12. The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an “advantage player,” to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such “advantage player” who is already a Silverton Rewards Club member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such “advantage player” will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.
13. Employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.
14. In the event that the Everi kiosk redemption system malfunctions or fails in any way, Silverton shall make every attempt to fix the kiosk redemption system that same evening. In the event that the Everi kiosk redemption system cannot be repaired by 10:00p.m. PST that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any prizes not distributed due to any malfunction or failure in Everi kiosk redemption system will not be issued at a later time.
15. Your participation in this Promotion shall be deemed an affirmative act of assent by You that You clearly understand and fully accept and agree to all Promotion rules, terms and conditions and to all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Rewards Club desk.
16. Prizes are non-transferable.
17. The Silverton reserves the right to alter or cancel any portion or all of this Promotion for any reason at any time and without notice, in its sole and absolute discretion.
18. The Promotion is valid only while supplies last; substitution gifts may be awarded in the sole and absolute discretion of the Silverton.
19. All Patrons participating in the Promotion must be at least twenty-one (21) years of age.
20. The Silverton shall not be responsible for any typographical or other errors in the printing, the offering, or the administration of this Promotion.
21. All prizes are subject to verification and approval by the Silverton and, if necessary or appropriate, the Nevada Gaming Control Board.

## Disputes/Choice of Law

By participating in the Promotion, you also hereby agree that:

22. All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be: resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
24. **ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.**
