



**Tax Day
Point Multipliers Promotion
2024-Rules**

Contest Duration

1. Silverton's "Tax Day Point Multipliers" promotion, (the "Promotion"), shall be held on April 15, 2024, between 12:01a.m. PDT until 11:59p.m. PDT or until terminated in the sole discretion of the management of Silverton Casino, LLC (the "Silverton").
2. The management of the Silverton reserves the right in its sole and absolute discretion to adjust the Promotion dates without prior notice for any reason.

Eligibility

3. The Promotion is open to all registered Silverton Rewards Club account members.

How The Point Multiplier Promotion Works

4. The Promotion consists of earning ten (10x) times points on reel games and two (2x) times points on video poker on advertised date of the Promotion between 12:01a.m. PDT until 11:59p.m. PDT.
5. Video Poker: \$4 coin-in on video poker games equals two (2) points.
6. Multiplier excludes "wheel poker", optimum play video poker machines and Flare Bar machines.
7. Slot Reels: \$1 coin-in on slot reel games equals ten (10) points.
8. Any eligible Patron earning points on an account other than their own account are subject to disqualification from the Promotion and void all potential accrued points.
9. It is the sole responsibility of each patron to verify their Silverton Club card is properly inserted into gaming machines at all times.
10. Bonus points may not be used toward the earning of earn & win gifts or drawing entries.
11. Point multipliers do not affect Silverton Rewards card tier status.
12. No limit on bonus points earned.
13. Earn bonus points in real time as you play. Bonus points go on your account instantly.
14. All points are subject to verification and approval of Silverton and, if appropriate, the Nevada State Gaming Control Board.

How To Enter

15. No activation required at the kiosk. Patrons may play any video poker or reel game using their Silverton Rewards Card.

Miscellaneous Rules

16. Valid identification is required for all Patrons. "Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If the winner is not a U.S citizen, a current valid passport or alien registration card is required.
17. The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an "advantage player," to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a Silverton Rewards Club member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.
18. Employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.

Your participation in this Promotion shall be deemed an affirmative act of assent by You that You clearly understand and fully accept and agree to all Promotion rules, terms and conditions and to all decisions regarding any interpretation of these rules by the Silverton. Disputes/Choice of Law

All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
27. **ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.**
