



"Earn & Win" Folding Chair Promotion

2024-Rules

Contest Duration

1. Silverton Casino, LLC ("Silverton") "Earn & Win" Folding Chair (the "Promotion"), shall run from 12:01a.m. PDT through 11:59p.m. PST Monday through Thursday, June 3rd -6th and June 17th -20th 2024.

Eligibility

2. The Promotion is open to all Silverton Rewards Club account members.

How The Promotion Works

3. Qualified Participants who earn two thousand five hundred (2,500) base points on each Promotion period, may redeem one (1) Folding Chair per person per promotional week.
4. Patrons must print their kiosk voucher ticket at any Silverton Redemption kiosk on Friday or Saturday, June 7th or 8th and a June 21st or 22nd 2024, and visit the Silverton Box Office to redeem Folding Chair.
5. Folding Chair will be distributed from the Silverton Box Office during normal business hours from 10:00a.m. PDT until 9:59p.m. PDT.
6. Base points are cumulative within the same Promotional date range. Base points will not roll over to the next earning period.
7. Patrons may earn a maximum of one (1) Folding Chair per person per promotional period; same day redemption is not required.
8. Eligible base points may be earned by playing slot reels, video poker or table games at Silverton.
9. Bonus point multipliers are excluded and are not eligible toward earn and win gift redemptions.
10. One (1) Folding Chair redeemable at the Silverton Box Office before 9:59p.m. PDT.
11. Patrons must present their kiosk voucher ticket, Silverton Rewards Club card, and valid identification to redeem.

Miscellaneous Rules

12. Valid identification is required for all Patrons. "Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If the winner is not a U.S citizen, a current valid passport or alien registration card is required.
13. The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an "advantage player," to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a Silverton Rewards Club member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.

15. In the event that the Everi kiosk redemption system malfunctions or fails in any way, Silverton shall make every attempt to fix the kiosk redemption system that same evening. In the event that the Everi kiosk redemption system cannot be repaired by 10:00p.m. PST that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any prizes not distributed due to any malfunction or failure in Everi kiosk redemption system will not be issued at a later time.

Your participation in this Promotion shall be deemed an affirmative act of assent by You that You clearly understand and fully accept and agree to all Promotion rules, terms and conditions and to all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Rewards Club desk.

All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be: resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
