



“Monkey Money Madness” Kiosk Boardgame Promotion 2024-Rules

Promotion Duration

1. Promotion period for the “Monkey Money Madness” Kiosk Boardgame Promotion (the “Promotion”) shall be played on Fridays and Saturdays, June 1, 7-8, 14-15, 21-22, 28-29, 2024, from 12:01a.m. PDT through 11:59p.m. PDT, unless earlier terminated at the sole discretion of the management of Silverton Casino, LLC (the “Silverton”).

Eligibility

2. The Promotion shall be open to registered Silverton Rewards club account members who meet the gaming criteria.
3. Patrons who sign up at the Players Club/Cashier for a Silverton Rewards club membership, will be automatically enrolled into the Promotion to participate.

How The Promotion Works

4. Patrons must earn two hundred (200) base points on any slot reel, video poker machine or at the table games to earn a swipe.
5. Patron may then redeem their swipe(s) at any Silverton Redemption Kiosk to participate in the Promotion.
6. Limit five (5) kiosk swipe redemptions per person per Promotion date, up to ten (10) swipes per weekend, same day redemption required.
7. Patrons will play the “Monkey Money Madness” boardgame. Board play will be continuous from the last position Patron landed on from previous swipe.
8. Patrons may win a prize by passing by a square or land directly on it.
9. If Patron completes the boardgame, and still has additional swipes, they may replay the board game again until the end of the Promotion.
10. Once a boardgame is complete, a new one will begin.
11. **Kiosk Prizes Include:**
 - a. Free Slot Play
 - b. Dining Offer
12. All kiosk game swipes must be redeemed between 12:01a.m. PDT through 11:59p.m. PDT on Promotion dates at any Silverton

Prize Redemption

13. Any kiosk swipes not redeemed, in accordance with these rules shall be forfeited.
14. Free slot play is valid 30 days from the date issued.
15. All Dining prizes are valid one day from date issued, at specified restaurants only, dates and dining times may vary based on hours of operations. Dining prizes may exclude Holiday’s.
16. Patrons may use one (1) dining coupon per dining visit. Multiple dining coupons, regardless of promotion, may not be used at one time.
17. It’s the Patron’s responsibility to read all coupon disclaimers for redemption details.

Miscellaneous Rules

18. Valid identification is required for all Patrons. “Valid identification” is defined as a current valid form of one of the following: state-issued driver’s license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If the winner is not a U.S citizen, a current valid passport or alien registration card is required.
19. The management of the Silverton reserves the right to determine that any Silverton Rewards club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an “advantage player,” to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such “advantage player” who is already a Silverton Loyalty Club Cage member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such “advantage player” will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.
20. Employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.
21. In the event that the Everi kiosk redemption system malfunctions or fails in any way, Silverton shall make every attempt to fix the Everi kiosk system that same evening. In the event that the Everi kiosk redemption system cannot be repaired by 10:00 p.m. PDT

- that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any prizes not distributed due to any malfunction or failure in Everi kiosk redemption system will not be issued at a later time.
22. Your participation in this Promotion shall be deemed an affirmative act of assent by You that You clearly understand and fully accept and agree to all Promotion rules, terms and conditions and to all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Players Club Cashier Cage.
 23. By participating in the Promotion, each winner gives the Silverton permission to have photographs taken of each winner and to use his or her name and/or likeness for advertising and publicity purposes. As a condition of the redemption of any prize in this Promotion, You agree that You shall execute an all-rights-of-publicity release, an affidavit of eligibility and a liability release.
 24. Prizes are non-transferable.
 25. The Silverton reserves the right to alter or cancel any portion or all of this Promotion for any reason at any time and without notice, in its sole and absolute discretion.
 26. The Promotion is valid only while supplies last; substitution gifts may be awarded in the sole and absolute discretion of the Silverton.
 27. All Patrons participating in the Promotion must be at least twenty-one (21) years of age.
 28. The Silverton shall not be responsible for any typographical or other errors in the printing, the offering, or the administration of this Promotion.
 29. All prizes are subject to verification and approval by the Silverton and, if necessary or appropriate, the Nevada Gaming Control Board.

Disputes/Choice of Law

By participating in the Promotion, you also hereby agree that:

30. All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;
31. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
32. **ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.**
