



"Table Games Hot Seat" Promotion

Rules-2024

Contest Duration

1. The Silverton's "Table Games Hot Seat" Promotion (the "Promotion") shall be held every Tuesday, Wednesday, and Thursday in July 2024.

Eligibility

2. The Promotion is open to registered Silverton Rewards Club account members who are actively gaming on any live table game during the specified drawing times.
3. It is the Patron's responsibility to present his or her own Silverton Rewards Club card to participate.
4. Patrons must present their card to a dealer at the Table no later than ten (10) minutes prior to each drawing time and must be actively gaming to be eligible.
5. Patrons are required to play at least the table minimum bet to be eligible to participate in the Promotion.
6. Winners will be determined solely on the "Watch" system, that will randomly select a Patron name and their Silverton Rewards Club card number.

How the Promotion Works

7. The Promotion will be held on Tuesdays, Wednesdays and Thursdays, July 2nd-4th, 9th-11th, 16th-18th, 23rd-25th, 30th and 31st, 2024, during the following times: 2:00p.m., 3:00p.m., 4:00p.m., 5:00p.m., 6:00p.m., 7:00p.m., 8:00p.m., 9:00p.m., 10:00p.m. PDT.
8. Silverton will randomly award one (1) winner each hour, fifty (50) dollars in Promotional Chips.
9. If there is a Patron actively playing on the immediate left and right of the winner, they will also receive \$10 in Promotional Chips, (if winner is seated at 1st or 6th spot, only the player seated at the 2nd or 5th spot, respectively will win). The current Patron playing must be playing with his or her own card.
10. Winners will be notified by Table Games management.
11. Playing at more than one table at a time is prohibited and will result in forfeiture of any prize.
12. Patrons will only be eligible to win one prize per hour.
13. Promotional Chips must be played on date issued only.

Prize Redemption

14. Silverton will make reasonable attempts to notify prize-winners of any prize won and shall not be responsible for a Patron leaving his or her table prior to notification.
15. Promotional Chips can be used for even money bets only and are one (1) play only.

Miscellaneous Rules

16. Valid identification is required for all Patrons. "Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If winner is not a U.S. citizen, a current valid passport or alien registration card is required.
17. The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an "advantage player," to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a Silverton Rewards Club member prior to the commencement of the Promotion, may be notified by the Silverton prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by the Silverton of any ineligibility or limitation determination as soon as possible after such determination is made.
18. Employees, consultants, advertising agencies and direct gaming vendors of the Silverton, together with their immediate family members, are not eligible to participate in or claim any prizes associated with this Promotion.
19. In the event that the "Watch" computer system malfunctions or fails in any way, Silverton shall make every attempt to fix the "Watch", system that same evening. In the event that the "Watch" system cannot be repaired by 10:00p.m. PDT

that same evening, Silverton shall not be liable for any prizes not distributed during that time period. Any prizes not distributed due to any malfunction or failure in "Watch" system will not be redrawn later.

Your participation in this Promotion shall be deemed an affirmative act of assent by You that You clearly understand and fully accept and agree to all Promotion rules, terms, and conditions and to all decisions regarding any interpretation of these rules by the Silverton. These Promotion rules will also be posted at the Silverton Club Cashier Cage.

By participating in the Promotion, each winner gives the Silverton permission to have photographs taken of each winner and to use his or her name and/or likeness for advertising and publicity purposes. As a condition of the redemption of any prize in this Promotion, You agree that You shall execute an all-rights-of-publicity release, an affidavit of eligibility and a liability release.

24. All Patrons participating in the Promotion must be at least twenty-one (21) years of age.

26. All prizes are subject to verification and approval by the Silverton and, if necessary or appropriate, the Nevada Gaming Control Board.

Disputes/Choice of Law

All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;
28. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;

ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.
