



Pass the Pigskin Video Poker Challenge
September 5, 2024- December 26, 2024
2024 Rules

Contest Duration

1. Qualifying period for the "Pass the Pigskin" Video Poker Challenge, (the "Promotion"), shall run every Thursday and Monday, beginning September 5, 2024, through December 26, 2024, during the NFL games. The Season Grand Finale Drawing will be held Thursday, December 26, 2024, at 6:00p.m. Actual dates of Promotion shall be determined by NFL game schedule.

Eligibility

2. The promotion is open to registered Silverton Rewards Club account members who meet the gaming criteria.

How The Weekly Promotion Works

3. The promotion is for all video poker games located only at the following bars on Silverton property.
 - Shady Grove Bar
 - Mermaid Lounge
 - Flare Bar
4. The promotion is only applicable for twenty-five cent denominations and above on Video Poker machines.
5. Max bet is required, and Patron must be playing with his/her own Silverton Rewards card.
6. The goal of the promotion is to hit any Natural Four of a Kind. When a Patron hits a Natural Four of a Kind, the bartender will place the "Football Trophy" on their machine. The "Trophy" will continue to move to any other machine that hits a Four of a Kind until the end of each NFL game quarter. The Patron with the "Trophy" at the end of each NFL game quarter shall receive a prize of fifty dollars (\$50) in free slot play.
7. Maximum of four (4) prizes shall be awarded each game night per bar.
8. All prizes are subject to verification and approval of Silverton Casino LLC and, if appropriate, the Nevada State Gaming Control Board.
9. Patron must notify bartender when they are dealt a four of a kind.
10. Bartender must verify all four of a kind before placing the Trophy.
11. Football Trophy is "reset" and returns to the Bartender at the beginning of each quarter.

How The Season Promotion Works

12. The promotion is only applicable for twenty-five cent denominations and above on Video Poker machines.
13. Max bet is required, and Patron must be playing with his/her own Silverton Rewards card.
14. The goal of the promotion is to hit any Natural Four of a Kind. When a Patron hits a Natural Four of a Kind, the bartender will issue the patron one (1) entry raffle ticket into the Season Long Grand Finale Drawing.
15. Patrons must deposit their raffle tickets into the drum located at the Silverton Box Office.
16. Drawing will be held Thursday, December 26, 2024, at 6:00p.m. PDT.
17. Only one (1) Drawing winner will be posted for twenty-four (24) hours at the Silverton Players Club Cashier Cage and must claim prior to 6:00p.m. on Friday, December 27, 2024.
18. All prizes are subject to verification and approval of Silverton Casino LLC and, if appropriate, the Nevada State Gaming Control Board.
19. Patron must notify bartender when they are dealt a four of a kind.
20. Bartender must verify all four of a kind before issuing a drawing entry.

Season Grand Finale Drawing Prize:

 - Two (2) Stadium Suite tickets to a Las Vegas Football home game (approx. retail value \$3,636) along with transportation to/from Allegiant Stadium.

If Patron does not claim within the 24 hour claim period, prize will be forfeited.

Miscellaneous Rules

"Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. If winner is not a U.S citizen, a current valid passport or alien registration card is required.

The management of the Silverton reserves the right to determine that any Silverton Rewards Club account member who is deemed in the sole and absolute discretion of the management of the Silverton to be an "advantage player," to be ineligible to participate in the Promotion, or to have their ability to participate in the Promotion otherwise limited.
