



Truck-tober Drawings 2024- Rules

Contest Duration:

1. Qualifying period of the "Truck-tober" drawings (the "Promotion") shall be from 12:01 a.m. PST on Sunday, September 1, 2024, through 5:59p.m. PST on Thursday, October 31, 2024, unless earlier terminated in the sole discretion of the management of Silverton Casino, LLC (the "Silverton").

Eligibility:

2. The Promotion is open only to registered Silverton Player's Club account members that meet the gaming criteria set forth in these rules.

How The Weekly Drawings Works:

3. One (1) entry will be earned by a Silverton Patron for every two hundred (200) base reel slot, video poker and table game points earned.
4. No max entries. All non-winning entries will be discarded weekly following Saturday's drawings held on September 7th, 14th, 21st, 28th and October 5th, 12th, 19th, 26th of 2024.
5. Entries will be electronic, and check-in is required on the day of the drawing by the Patron. Check-in will begin at 4:00p.m. PST and continue up until 5:59p.m. PST.
 - a) Patrons must activate entries by inserting their Silverton Rewards Club card into a slot or video poker machine and generating a play rating, Patrons must pull their Silverton Rewards Club card out prior to 5:59p.m. PST to ensure all entries are activated.
 - b) Patrons can also activate entries by swiping at any Silverton redemption kiosks on the casino floor.
 - c) It is the sole responsibility of the Patron to have their entries activated by 5:59p.m. PST. No exceptions will be made to adjust entries or activate entries after 5:59p.m. PST.
6. Each Saturday, September 7th, 14th, 21st, 28th, 2024 and October 5th, 12th, 19th, 26th 2024 at 6:00p.m. PST, five (5) Patrons will be randomly drawn to determine the winners of the Promotion.
7. Drawing area located in front Silverton Box Office. Patrons will have three (3) minutes to claim once their name and card number is announced, Patrons must be present to win.

If the drawn Patron or a representative of a drawn Patron fails to notify a Silverton drawing official in the drawing area located in front of Silverton Box Office within the three (3) minute time frame, and or fails to show a valid form of ID and Silverton club card they will be ineligible to claim, replacement names will continue to be drawn until all five (5) winners are verified.
9. Each Patron with a confirmed winning entry may choose an envelope from the prize board. The Patron will win the corresponding prize contained in the envelope.

How The Grand Finale Drawing Works

10. Qualifying period for the "Truck-tober" Grand finale drawing shall be from 12:01 a.m. PST on Sunday, September 1, 2024, through 5:59 p.m. PST on Thursday, October 31, 2024,
11. **Grand Finale drawing will be held on Thursday, October 31, 2024, at 6:00pm PST.**
12. One (1) entry will be earned by a Silverton Patron for every two hundred (200) base slot reel, video poker and table game points earned.
13. No max entries. All entries will be discarded after the 6:00p.m PST drawing held on Thursday, October 31, 2024.
14. Entries will be electronic, and check-in is required on the day of the drawing by the Patron. Check-in will begin at 4:00p.m. PST and continue up until 5:59p.m. PST.
 - d) Patrons must activate entries by inserting their Silverton Rewards Club card into a slot or video poker machine and generating a play rating, Patrons must pull their Silverton Rewards Club card out prior to 5:59p.m. PST to ensure all entries are activated.
 - e) Patrons can also activate entries by swiping at any Silverton redemption kiosks on the floor.
 - f) It is the sole responsibility of the Patron to have their entries activated by 5:59p.m. PST. No exceptions will be made to adjust entries or activate entries after 5:59p.m. PST on Thursday, October 31, 2024.

19. **Should the winner win a "Truck," Silverton will provide the winner with a list of approved dealerships at which the winner may select a vehicle from. The winner will then be given a credit of \$37,000, which will be paid directly to the dealership.**

 21. A substitute prize of **\$25,000 cash** may be taken in lieu of the **\$37,000 credit for Truck.**
 22. In the event the winner chooses a vehicle less than **\$37,000**, the winner forfeits the remaining balance.
 23. **Grand Prize Winner will have 72 hours to notify Silverton's "Vice President of Marketing" with his/her final decision to claim.**

Miscellaneous Rules

"Valid identification" is defined as a current valid form of one of the following: state-issued driver's license with photograph, state-issued identification card with photograph, U.S. military identification card with photograph, or passport issued by a government. Any prizes not distributed due to any malfunction or failure of Everi computer system will not be redrawn at a later time.

Disputes/Choice of Law

All issues and questions concerning these rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision made in accordance with NRS § 463.362;

Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion, or to any prize awarded pursuant to this Promotion, which are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and are not resolved pursuant to a regulatory decision made in accordance with NRS § 463.362, shall be resolved individually, without resort to any form of class action; and filed only in the state or federal courts situated in Clark County, Nevada, and the Promotion entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action;
39. **ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, AND IN NO EVENT SHALL THEY INCLUDE ANY ATTORNEYS' FEES; AND UNDER NO CIRCUMSTANCES SHALL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM ANY PUNITIVE, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OF ANY KIND, OTHER THAN DAMAGES FOR ACTUAL OUT-OF-POCKET EXPENSES, AND YOU HEREBY WAIVE ANY AND ALL RIGHTS TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED.**
